The minimum charge for each HWB will be the current monthly average of 1 Gallon of Diesel

Catalina has adopted a fuel surcharge calculation method for both LTL and Truckload services based on the fuel prices published weekly

by the U.S. Department of Energy. This method closely links the fuel surcharges to prevailing market prices for diesel fuel and should help Catalina and its customers respond more quickly to changes in fuel-related costs.

Fuel surcharge percentages for the shipments will be subject to monthly adjustments.

The adjustment will be made according to the table above. The fuel surcharge will be based on the price per gallon of diesel fuel stated by the U.S. Department of Energy in their weekly reports each Monday. The effective periods will be from 1st to the end of each month.

The surcharge percentage will be reflected on your Catalina Invoice.
